### REQUEST FOR PROPOSALS FOR SECURITY SYSTEMS SERVICE AND SUPPORT

Notice is hereby given that the Burlington County Bridge Commission ("Commission") is requesting the submission of proposals ("Proposal") from qualified firms ("Firm") to provide a Service and Support Agreement ("SSA") relating to the Commission's Video Management System ("VMS"), CCTV Camera/Audio System, Access Control System ("ACS"), and various supporting infrastructure. These systems are already in place and functioning at various Commission buildings and sites. The projected term for this SSA is for a period of one (1) year with up to two (2) additional one (1) year renewals.

This RFP is being solicited through a fair and open process in accordance with N.J.S.A. 19:44A-20.4 et seq.

Nothing herein is intended to exclude any responsible Firm or in any way restrain or restrict competition. All responsible Firms are encouraged to submit proposals.

All firms will be required to comply with the requirements of P.L. 1975, c. 127 (N.J.A.C. 17:27) Affirmative Action, P.L. 1977, c. 33 (N.J.A.C. 52:25-24.2) Statement of Ownership, and P.L. 2004, c. 57 and P.L. 2009, c.315 as amended (N.J.S.A. 52:32-44) New Jersey Business Registration.

Proposals must be received by the receptionist during regular Commission business hours no later than Tuesday, December 7, 2017 at 11:00 AM, prevailing time, addressed to the Burlington County Bridge commission, 1300 Route 73 North, PO Box 6, Palmyra, NJ 08065-1090, ATTN: Purchasing. All Proposals must be enclosed in sealed envelopes and should bear the name and address of the Firm and "Request for Proposals for Security Systems Service and Support" on the outside, including on the outside of any delivery service envelope. Regular Commission business hours are Monday through Friday, 8:30 AM to 4:30 PM subject to Commission Holidays.

Facsimile Submissions will not be accepted. Late Submissions will not be accepted and will be returned unopened to the Firm. The Commission reserves the right to reject any and all Submissions, to waive any requirement of the RFP, to modify or amend (with the consent of the Firm) the Submission, and to effect any agreement deemed to be in the best interest of the Commission. All Submissions become the sole property of the Commission.

The preparation of the RFP Submission shall be at the expense of the Firm. The Commission will not reimburse any Firm for any costs associated with the preparation or submittal of any Submission. It is the responsibility of the Firm to fully examine the RFP and to respond accordingly.
